



ANNUAL GENERAL MEETING held at Williton on 19th September 2020

The DEPG held its Annual General Meeting at Williton Diesel Depot. The meeting was held inside the main diesel shed which had been specially prepared for the occasion with the seating being carefully spaced out to 2m separation and the main doors pinned open to allow as much natural ventilation as possible. The formal business of the meeting was dealt with efficiently with the Minutes of the previous AGM being accepted as a true record. The Chairman, Martin Howard, read out a prepared statement to clarify some apparent confusion over Board member responsibilities arising from mid-term changes. He then went on to give a comprehensive report about the group's reduced activities since the last AGM and the implications for the future.

The Treasurer, Julien Weston, gave a report about the financial situation of the Group and also emphasised the reduced income we have suffered this year due to the total lack of train running on the WSR. There were votes to accept the accounts, agree the simplified financial accounting model and appoint auditors which were all accepted unanimously.

The election of Officers was a formality with the previous Board being re-elected to office unopposed and with the addition of Neil McCannon as Vice Chairman. The board members and their primary roles are listed below:

The formal business being concluded after approximately 45 minutes, the Chairman then invited the WSR Vice Chairman, Mark Smith, to give a presentation on the WSR PLC perspective. He delivered an interesting and informative speech which certainly helped to illustrate the difficult position the PLC has been in, and how they are proposing to work towards a staged reintroduction of train working from December onwards.
